

## LAWS OF NEW YORK, 2002

## CHAPTER 38

AN ACT to amend the state law, in relation to the descriptions of certain assembly and senate districts and repealing certain districts to make certain technical corrections to such districts

Became a law April 24, 2002, with the approval of the Governor. Passed on message of necessity pursuant to Article III, section 14 of the Constitution by a majority vote, three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivisions 4, 8, 12, 13, 14, 15, 16, 17, 19, 24, 25, 29, 30, 31, 36, 67, 69, 70, 75, 93, 94, 95, 105, 110, 131 and 138 of section 121 of the state law, as added by a chapter of the laws of 2002, amending the state law, relating to creating assembly and senate districts, as proposed in legislative bill numbers S. 6796 - A. 11014, are repealed and added to read as follows:

4. Fourth district. 8. Eighth district. In the county of Suffolk, that part of the town of Babylon bounded by a line described as follows: Beginning at a point where the Babylon/Islip town line meets Robert Moses State Parkway, thence southerly along said parkway to the waters of the Atlantic Ocean, thence westerly along said ocean to the Suffolk/Nassau county line, thence northerly along said county line to the shoreline of the Great South Bay, thence easterly along said shoreline to the Santopogue Creek, thence northerly along said creek to Montauk Highway, thence along said highway to the Santopogue Creek, thence northerly along said creek to a point on a line extended westerly from Shirley Lane, thence westerly along said line extended to East Drive, thence northerly along said drive to Babylon Farmingdale Road, thence westerly along said road to Straight Path, thence northerly along said path to Herzel Boulevard, thence easterly along said boulevard to 14th Avenue, thence southerly along said avenue to 2nd Street, thence easterly along said street to Little East Neck Road North, thence northerly along said road to Outlook Avenue, thence easterly along said avenue to Belmont Avenue, thence northerly along said avenue to Throop Street, thence westerly

along said street to Lewis Avenue, thence northerly along said avenue to Young Street, thence easterly along said street to Belmont Avenue, thence northerly along said avenue to Southern State Parkway, thence easterly along said parkway to the outflow of Elda Lake, thence southerly along said outflow to the east shore of Elda Lake, thence southerly along said shore to Phelps Lane, thence easterly along said lane to Deer Park Avenue, thence northerly along said avenue to Hunter Avenue, thence easterly along said avenue to Whittier Avenue, thence southerly along said avenue to Thoreau Road, thence easterly along said road to Emerson Avenue, thence northerly along said avenue to Hunter Avenue, thence easterly along said avenue to Babylon/Islip town line, thence southerly along said town line to its intersection with the Robert Moses State Parkway, the point of beginning; that part of the town of Islip bounded by a line described as follows:

creek to Brook Street, thence easterly along said street to Saint Louis Avenue, thence northerly along said avenue to Fitchburg Street, thence easterly along said street to Chicago Avenue, thence southerly along said avenue to Brook Street, thence easterly along said street to Saxon Avenue, thence northerly along said avenue to Ithaca Street, thence westerly along said street to Saint Louis Avenue, thence northerly along said avenue to Spur Drive South, thence westerly along said drive to a line extended northerly from Saxon Avenue, thence northerly along said line extended to Southern State Parkway, thence easterly along said parkway to Carleton Avenue, thence northerly along said avenue to Spur Drive North, thence easterly along said drive to the Central Islip Psychiatric Center, thence northerly along the east border of said center to a point northerly of Cedarhurst Street, thence northeasterly along a line extended from said point to Greenlawn Avenue at a point midway between Seacliff Street and Rockaway Street, thence northerly along said point to Seacliff Street, thence easterly along said street to Lowell Avenue, thence along a line extended easterly from said avenue to Connetquot Brook, thence northerly along said brook to a line extended easterly from Allocco Court, thence westerly along said line extended to a point where Allocco Court meets the Connetquot River State Park boundary, thence southerly and westerly along said boundary to Deerpath Road, thence northerly along said road to Allwood Avenue, thence easterly along said avenue to Connetquot River State Park boundary, thence northerly along said boundary to Woodland Avenue, thence westerly along said avenue to Prospect Street, thence northerly along said street to Ridge Avenue, thence easterly along said avenue to Connetquot Avenue, thence northerly along said avenue to Windsor Place, thence westerly along said place to the Long Island Rail Road, thence easterly along said railroad to Veterans Memorial Highway, thence northerly along said highway to Old Nichols Road, thence along said road to a line extended westerly from Sioux Street, thence northeasterly along a line extended from Old Nichols Road to the Islip/Smithtown town line, thence easterly along said town line to North 6th Street, thence southerly along said street to Victory Drive, thence westerly along said drive to West 7th Street, thence southerly along said street to Richmond Boulevard, thence westerly along said boulevard to Canoe Place, thence southerly along said place to Seneca Street, thence easterly along said street to Parkway Boulevard, thence southerly along said boulevard to North Ontario Street, thence westerly along said street to Canoe Place, thence southerly along said place to Motor Parkway, thence westerly along said parkway to Breeze Avenue, thence southerly along said avenue to a line extended to I-495, thence along said line extended to I-495,

thence easterly along said interstate to a point intersecting Juniper Avenue extended, thence southerly along said line extended to Expressway Drive South, thence westerly along said drive to Terry Road, thence southerly along said road to Parkwood Street, thence westerly along said street to Forest Drive, thence southerly along said drive to Johnson Avenue, thence easterly along said avenue to May Court, thence southerly along said court to a line extended to the Long Island Rail Road, thence along said line extended to the Long Island Rail Road, thence westerly along said railroad to the eastern boundary of the Connetquot River State Park, thence southerly, easterly and southerly along said boundary to Veterans Memorial Highway, thence easterly along said highway to Kenwood Drive, thence southerly along said drive to 8th Street, thence easterly along said street to Louis Kossuth Avenue, thence southerly along said avenue to Madison Street, thence easterly along said street

to Sycamore Avenue, thence southerly along said avenue to its intersection with Pond Road, the point of beginning.

12. Twelfth district. § 3. If any clause, sentence, paragraph, section or part of this act shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been rendered.

§ 4. This act shall take effect on the same date as a chapter of the laws of 2002 amending the state law, relating to creating assembly and senate districts, as proposed in legislative bill numbers S. 6796 - A. 11014 takes effect.
